Their details are as follows:

Mr. Li Honghui, aged 49, served as the officer, deputy section chief and section chief of the General Office of the Department of Industry and Communication Financing (工業交通財務司), officer of the General Office of the Department of Industry and Communication, deputy head of the General Information Division of the Department of Industry and Communication, deputy head of the Industry Division and deputy head of the Industry Division I of the Economic and Trade Department, deputy head and head of the Planning and Investment Division, head of the General Office, head of the Environment and Resources Division of the Economic Construction Department and deputy director of the Investment Appraisal and Censoring Centre under the MOF from August 1990 to June 2014.
